

CHAPTER V

CONCLUSION AND SUGGESTION

5.1. Conclusion

As mentioned in chapter one, the purpose of this research is to find out the perception of the students for online assessment using Schoology. In order to answer the main research problem, the researcher makes three sections which focus on the online assessment, Schoology as the online platform, and learning media. The researcher uses questionnaire and interview to collect the data from the participants. There are 15 students participating in this study from Morphology and Syntax Class A in academic year 2019-2020.

After conducting the study, the researcher is able to analyze the data and find the answer of the main research problem. The findings show that the majority of the students have positive responses toward online assessment using Schoology in Morphology and Syntax class. They agree that using Schoology has led them to be more discipline in doing the exercises that are given by the lecturer. Schoology gives more insights for students who are also teacher candidates to build a learning material that can be used online.

5.2. Suggestions

According to the findings of the study, the writer would like to address her suggestions to 3 (three) parties: the students, teacher or lecturer, and future researcher.

5.2.1. Suggestion for Students

Teacher candidates of English Department are suggested to improve their knowledge to use and operate the online platform for education such as Schoology. It is very beneficial for them in the future when they have to teach in online classes.

5.2.2. Suggestion for Teacher and Lecturer

The findings of this research show that students respond positively toward the use of Schoology, as the LMS. Therefore, teachers and lecturers are suggested to consider the usefulness and efficiency of online assessment in this digital era. It is very helpful for teachers and lecturers to control and communicate with the students. Especially this year that all over the world has been reshaped by the pandemic caused by the Covid-19 that has restricted the mobility of people greatly, making them stay at home to help cut the chain of infection.

5.2.3. Suggestions for Future Researcher

The researcher hopes that there will be more similar studies conducted about the online assessment using online platform such as Schoology. Since this research only involves undergraduate students' perception, future researchers should be able to investigate more diverse subjects, both in numbers and categories. Investigating the perception of students toward different LMSs would also be a very interesting thing to reveal further.
