CHAPTER V

CONCLUSION AND SUGGESTION

This chapter presents conclusion about this study and suggestions related to the literature field and for further studies are also given.

5.1 Conclusion

The analysis of the finding leads the writer to give some conclusion. There are three factors that motivate Armand in chasing Marguerite. First is the beauty of Marguerite and the contradictive character that Marguerite has, second is to fulfill the love needs of Armand and the last, the third is to fulfill Armand's self actualization.

The first factor comes from Marguerite herself. It is found that Armand is attracted by how beautiful Marguerite, and the glamour life that Marguerite has. Armand also attracted to Marguerite because of the uniqueness of her personality, the contradictory personality that she has. Though the other courtesan will happily accept every man and money that comes, but Marguerite rejects all of that because for her those who come only want to satisfy their needs, not for the real love that she need, Marguerite still has a pride and independence. In addition, Marguerite herself wants to find someone who is at the same age and can accept whatever she is.

The second factor comes from Armand's side in relation to Maslow's theory of motivation, the needs of love. This factor strongly affects Armand, because he already fulfills his basic needs except the needs of love. The writer found that since the death of Armand's mother, he can not find the love that he needs and although he has a sister, he can not feel the love that he is looking for. He wants to find the needs of belonging and he finds it through Marguerite's personalities. The love that Armand feels from Marguerite is so intense, full with up and down. It makes his life change, the love that makes his heart tremble since Marguerite leaves a lot of impressions to Armand.

The third is to fulfill Armand's self actualization, it is mentioned before in the analysis that every people have different goal and dream to actualize what they want in their life. Armand in this novel wants to actualize himself and fulfill his goal when he become Marguerite's lover, that is why he is motivates to chase Marguerite in order to actualize himself.
