

CHAPTER V

CONCLUSION AND SUGGESTIONS

5.1 Conclusion

The purpose of this study is to find out about the challenges and opportunities faced by students in Academic Vocabulary course in learning vocabulary online. Nineteen (19) students from one entire class of Academic Vocabulary course in English Education Study Program of Widya Mandala in the batch of 2020/2021 academic year and also the Academic Vocabulary teacher participated in this study. The participant filled out the questionnaire distribute by the researcher through Google form. The researcher also did the interview with 3 respondents and the lecturer of Academic Vocabulary.

Based on the result of data analysis, it can be concluded that most of the students prefer to choose online learning than face-to-face learning.
