#### 5.1 Conclusion

## **5.2 Suggestion**

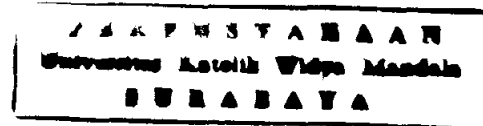
