



## **BAB 4**

### **KESIMPULAN DAN SARAN**

#### **4.1 Kesimpulan**

Setelah menjalankan Praktik Kerja Profesi Apoteker (PKPA) di Rumah Sakit Umum Daerah (RSUD) Haji Surabaya pada tanggal 02 Januari – 28 Februari 2023, dapat disimpulkan bahwa mahasiswa calon Apoteker mengalami:

1. Peningkatan pemahaman tentang peran, fungsi, dan tanggung jawab apoteker dalam pelayanan kefarmasian di Rumah Sakit.
2. Peningkatan wawasan, pengetahuan, keterampilan, dan pengalaman praktik untuk melakukan pekerjaan kefarmasian di Rumah Sakit.
3. Peningkatan pemahaman terhadap konsep serta praktik asuhan kefarmasian dalam pelayanan kefarmasian di Rumah Sakit.
4. Peningkatan kemampuan untuk membuat keputusan serta melakukan tindakan yang tepat berdasarkan keilmuan kefarmasian, etik, dan hukum untuk penyelesaian problema praktik kefarmasian di Rumah Sakit.
5. Peningkatan kemampuan berkomunikasi dengan pasien dan bekerja sama dengan sejawat tenaga profesi kesehatan lain terkait dengan pengobatan rasional kepada pasien.

#### **4.2 Saran**

1. Sebaiknya Apoteker memberikan diskusi dengan mahasiswa calon Apoteker paling tidak seminggu 3 kali dan untuk kasus yang diberikan oleh supervisor bisa diberikan di awal, jika jadwal mahasiswa calon Apoteker dengan supervisor tersebut.
2. Sebaiknya para Staff Apoteker dan para Staff Karyawan dapat lebih ramah dalam memberikan penjelasan terkait dengan pertanyaan yang diajukan oleh mahasiswa calon Apoteker selama Praktik Kerja Profesi Apoteker.
