

## **CHAPTER V**

### **CONCLUSION**

This research discusses the failure of masculinity in the movie entitled "A Raisin in the Sun". This research takes the topic of failure of masculinity, namely the failure of masculinity that occurs in male characters associated with blacks and whites in the movie "A Raisin in the Sun". Movies are also related to literary works, therefore the researcher took the topic of failure of masculinity in the movie entitled "A Raisin in the Sun". There are two problem formulations discussed in this research. First, how the failure of masculinity occurs to the four male characters in the movie entitled "A Raisin in the Sun". The researcher used qualitative descriptive methods in this research. Data is in the form of words, sentences, phrases, and clauses in the movie. Data was taken from the movie "A Raisin in the Sun" and the data was categorized based on failures of masculinity.

This research has found results from the problem formulation. The first problem in the problem formulation is analyzing the failure of masculinity experienced by four male characters including Walter Lee, George Murchison, Joseph Asagai, and Carl Lindner in the movie entitled "A Raisin in The Sun". Failure of masculinity is how a man fails in his masculinity, such as not being

responsible, not being a leader in a family or social environment, not being a protector of women, and even failing in sexual matters which makes a man gay or called a homosexual.

The second problem formulation is the effect of the failure of masculinity experienced by the four male characters on themselves in the movie entitled "A Raisin in The Sun". As a result of this effect, the male character experiences problems with himself. Especially Walter Lee who is the main character and finds many failures in his masculinity. Walter Lee experienced failed hegemonic masculinity, failed subordinate masculinity, failed complex masculinity, and failed marginal masculinity, which resulted in the effects of failed masculinity including depression, emotional suppression, feelings of loneliness, and lying.

This research has limitations in examining masculinity failure and the effects of masculinity failure. This research analyzes the failure of masculinity and the effects of failure of masculinity which especially occurs on black people. Future researchers can develop similar topics more specifically. Researchers can use different data to develop failures of masculinity. Future researchers can analyze masculinity or patriarchy with the same data.
