CHAPTER V CONCLUSION AND SUGGESTIONS

In this chapter, the writer will conclude the previous chapters and give suggestions for the institution, students and lecturers of Widya Mandala University.

5.1 Conclusion

All the systems of reduplication in Sasak language can be summarized into 39 formulae. The easiest approach which is used by the writer is generative morphology that usually present language in rules. From the data/analysis, the writer conclude that:

- (1). The reduplication in Sasak language is in a place of all content words such as noun, verb, and adjective.
- (2). The reduplications of Sasak language do not only occur on the root itself but also on the prefix and suffix.
- (3). The meanings of reduplication in Sasak Language indicate pluralization, prolonged action, causative, imperative, reciprocal action, frequency or repeating action, emphasis, and also comparison.
- (4). Reduplication in Sasak in terms of reduplication of the root, may have two major divisions: complete reduplication and partial reduplication, i.e. the reduplication of the first syllable of the root. The first type indicates plurality, emphasis or repeated actions which are divisions of units, and the second type indicates plurality, emphasis, or recursion of totality.
