#### CHAPTER V

### **CONCLUSION AND SUGGESTION**

#### 5.1 Conclusion

In learning English, the learners should master the four skills of English: listening, speaking, reading; and writing. Those skills are all important. Among the four skills, writing is considered as the most difficult skill to be mastered. Writing is more complicated because in writing the writer should be able to combine his or her idea or information in a written form by taking account on grammar or usage. To give more practice to the learners, the teacher can give homework and put writing as one of extra curricular activities. By placing writing as one of extra curricular activities, the teacher will have more time to guide the students in writing.

The writer realizes that her suggested technique is not the best technique to help teachers in teaching writing, especially in senior high school. Finally, the writer must admit that her study is far from being perfect. She hopes that other
