

## **BAB 5**

### **KESIMPULAN DAN SARAN**

#### **5.1 Kesimpulan**

Berdasarkan hasil penelitian yang berjudul Studi Penggunaan Asetosal pada Pasien Penyakit Jantung Koroner Rawat Inap di RSUD Kabupaten Sidoarjo periode Desember 2015 sampai Agustus 2016 diperoleh kesimpulan sebagai berikut :

- Pada 30 pasien, yang menggunakan asetosal tunggal (1x75mg) PO sebanyak 27 pasien (90%). Kombinasi dengan klopidogrel (1x75mg) PO sebanyak 3 pasien (10%) sudah sesuai dengan *guidelines* yang ada.

#### **5.2 Saran**

Diperlukan penelitian lebih lanjut dengan menggunakan metode prospektif agar peneliti dapat mengamati kondisi pasien dan permasalahan terkait terapi obat secara langsung, dapat berinteraksi dengan pasien, dokter dan para klinisi serta dihasilkan pola penggunaan obat yang lebih representatif.
