CHAPTER V

CONCLUSION AND SUGGESTION

5.1. Conclusions

As it mentioned in chapter one, the aim of this research is to recognize the lecturer's perception on the implementation of a university learning management system: https://bella.ukwms.ac.id/ in EFL Classrooms of English Department at Widya Mandala Catholic University Surabaya. As a mean to answer the main research problem, the author construct two sections. The first section, which focuses on the instructions, courses and submission date in bellaukwms, meanwhile the second section focuses on scoring system, students' attendance list and lecturer contact information on bellaukwms. The author make use of a questionnaire to gather the data from the respondents. There are 18 lecturers participating in this research.

After conducting the research, the author is able to examine the data and find out the answer for the main research problem. The findings appears that the majority of the lecturers have positive responses toward the implementation of a university learning management system: https://bella.ukwms.ac.id/ in EFL Classroom. Almost all lecturers agree that the implementation of a university learning management system: https://bella.ukwms.ac.id/ bring so many advantages rather than the disadvantages. Besides that, the implementation of bellaukwms provides some essential stuffs, which will be much easier for the lecturers during preparing and teaching the material for both asynchronous or synchronous teaching-learning activity, checking the students' attendance list, giving the grading towards the all thecourse they have taught to the students.

5.2. Suggestions

Based on the findings of the study that has explained above, the author would like to provide her suggestions towards 2 (two) parties, those are: the lecturers and the future researcher.

5.2.1. Suggestion for the Lecturer

This study shows us that the implementation of a university learning management system: https://bella.ukwms.ac.id/ in EFL Classroom still shows a possibility to get either positive or negative responses from the lecturers. On the other hand, using university learning management a system: https://bella.ukwms.ac.id/ in English Department EFL Classroom can be an effective method to monitor the students' progress during the teaching and learning activities either asynchronous or synchronous. Not only that, nowadays we currently live in an era dominated by technology, if we do not started to familiarize ourselves with technology, slow but sure we will be left behind in some aspect.
