Comments to the Author

Review the manuscript: Parenting style, child emotion regulation and behavioral problems: The moderating role of cultural values in Australia and Indonesia.

Introduction: The section appropriately introduced the topic of the manuscript; however, I would recommend adding a brief statement at the end of the second paragraph identifying the purpose of the study. This helps inform the reader prior to beginning the literature review.

Literature review: I appreciate the authors' culturally competent approach to the literature review.

Methods / Discussion: Participants - While this study emphasized the role of cultural values, I found it interesting that the sample was made up of 92% women from Australia and 90% from Indonesia, and further 81% from Australia identified as Caucasian. While this study pointed out country-level indicators I would suggest that it also explore the sample make-up. Ultimately, rather than having a study that was representative of 'parents' it was a study representative of mother-child relationships. While I understand that gathering participants can be challenging, I would recommend that the authors highlight these points in the limitations. Lastly, I appreciated the authors citing direction for future research, in addition, I would suggest they also discuss practical implications. How can the findings in the study be applied beyond research?

Additional note: there were several minor typos throughout the submission. For example: Page 15, "An unexpected flinging..", correct to finding.

Overall, this study was well organized and well thought-out; however, I believe consideration should be made for the above suggestions prior to publication.

Comments to the Author

This manuscript seeks to examine the moderating role of cultural values on parenting styles and child emotional and behavioral outcomes in Australia & Indonesia. Authors used hierarchical modeling to test their hypotheses. While this is a well written article, this article may be better suited for another journal.

Needs an Abstract

Introduction

- Opening sentences needs to be more alluring
- P. 2, In. 38- "psychological adjustment" should not be discussed when talking about behaviors. They're not the same.

Methods

P. 9- Please offer an example of the "permissive" question items asked.

Results

P. 12-13- Please explain why "It is interesting to note that emotion regulation was higher among Australian children than Indonesian children". What is interesting about it?

Discussion

- P. 17- Authors mention "A point of theoretical interest", though no theory was discussed in the literature review Reference should start on its own page
