As a lady, Eliza's personality has changed in language, appearance, manners, and outlook. Here, Eliza's speech has changed from cockney accent into Standard English. She does not have difficulty in the pronunciation in spite of her halting speech. Eliza has done a reformation and an improvement in her grammar and pronunciation. Furthermore, she had successfully acquired the articulation of speech as a duchess.
