5.1. Conclusion

Having discussed Lawrence's novel, the writer would like to summarize for a conclusion. D. H. Lawrence's, *Lady Chatterley's Lover* is a novel that was published in 1960. It tells about a dissatisfaction of a lady in her unhappy marriage. Here, the writer concludes some causes and effects of the unfaithfulness of Constance Reid based on the discussion on chapter four.
